#### TERMS AND CONDITIONS FOR "24 DAYS OF SUMMER SURPRISES" PROMOTION

# ELIGIBILITY

# HOW TO ENTER

- "Participating Retailers" means any retailer at the Centre listed in Annexure A, except for any Excluded Retailer. An "Excluded Retailer" means any of the excluded retailers listed in Annexure B. An "Ineligible Transaction" means any transaction recorded on an invalid receipt, as specified in condition 8 below.
