TERMS AND CONDITIONS FOR "PASSPORT TO ADVENTURE" PROMOTION

FINAL

- 1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this "PASSPORT TO ADVENTURE" Promotion ("Promotion") is deemed acceptance of these Terms and Conditions.
- 2. The "Promoter" is Jones Lang Lasalle (NSW) Pty Limited (ABN 37 002 851 925) of Level 8, 644 George Street, Sydney NSW 2000, telephone: 02 8275 6777 ("JLL"). The Promotion will be conducted at Karingal Hub Shopping Centre, 330 Cranbourne Road, Karingal VIC 3199 ("the Centre").

ELIGIBILITY

- Subject to condition 4, this Promotion is only open to Australian residents aged 16 years or over.
- 3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parental/guardian of the entrant must read and consent to these Terms and Conditions. Parents/Guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion
- 4. The following are ineligible: (i) employees of the Promoter or any of the tenants or retailers at the Centre or any of the Promoter's agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

PROMOTION PERIOD

5. This Promotion commences at 10:00am AEDT on 04/03/2022 and ends at 2.00pm AEDT on 20/03/2022 or once stocks of Passports run out, whichever is first ("Promotion Period"). The Promotion Period for the Instant Prizes – Claw Machine ends at 2.00pm AEDT on 20/03/2022 or once all two thousand and six (2,006) Instant Prizes have been won, whichever is first.

HOW TO ENTER

- 6. "Participating Retailers" means any retailer at the Centre listed in Annexure A, except for any Excluded Retailer. An "Excluded Retailer" means any of the excluded retailers listed in Annexure B. An "Ineligible Transaction" means any transaction recorded on an invalid receipt, as specified in condition 8 below. "Passport" means a promotional card which contains a QR code and token ("Token") which can be collected from the Centre Court between 10:00am AEDT to 2:00pm AEDT during each day of the Promotion Period.
- 7. To enter this Promotion, eligible individuals must, during the Promotion Period, undertake the following steps:

- (f) Input the details of each Participating Retailer/s that they purchased from that makes up their Qualifying Spend and then
- (g) Submit the fully completed online entry form.

Upon completing the above steps, eligible individuals will be placed in the major prize draw ("Major Draw").

Instant Prize – Claw Machine
