Terms and Conditions

- 1 These terms and conditions are for all entrants who enter the 'Warm Up Your Winter Wardrobe' Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.

ELIGIBILITY

- 3 This Promotion is only open to VIC residents who are 18 years old or older.
- 4 The following persons are ineligible for the Promotion: (i) directors and employees of the Promoter, its related companies or any of its agencies.
- 5 Retailers and staff that are associated with the Promotion (ii) the spouse, defacto spouse, parent, child or sibling of an aforementioned excluded person; and (iii) any person who the Promoter has previously notified is permitted to enter the Promoter's promotions, however receipts must not be from the retailer they are employed by.
- 6 One entry per person per single spend.

HOW TO ENTER

- 12 It is a condition of entering the Promotion that entrants agree for their personal information to be added to the Promoter's database and to be used in accordance with the purposes set out in these Terms and Conditions, of which they may opt out at any time.

INVALID RECEIPTS

- 6 The following receipts are not valid receipts for the purpose of the Promotion: (a) receipt(s) from non-participating retailers (b) receipts from click and collect or online deliveries; (c) receipt(s) recording bill payments and prescription medicine, (d) receipts recording Layby payments except where a Layby is finalised and payment completed during the Promotion Period; (e) receipts recording redemption of gift card purchases, store credit, refunds and exchanges; (f) ATM receipts and (h) receipts that the Promoter has reasonably determined to have been tampered with or have been obtained fraudulently or are a reprint of the original receipts.
